NOTE: *these are not official announcements from agencies, but notes I took during the meeting. If I misrepresented your agency or policies in anyway, please let me know and I will issue a correction.*

Updates sent to/from the Pikes Peak Continuum of Care:

- The Homeless Isolation Shelter (HIS) is indeed open and able to provide a safe place for individuals without homes to respite from COVID
- The HIS is not a medical shelter, but there is a medical professional on staff at all times that can help monitor symptoms and call 911 if someone's symptoms worsen.
- We also have an on-call Medline that is monitored by physicians should they need to be consulted on any medical issue that may arise.
- Every individual at the shelter has a cot and linens spaced 6 feet apart from one another.
- Meals are available, showers, and access to clean clothing are also available at the HIS.
- In addition, books, DVD's and Chromebooks are there for individuals to utilize so they don't get bored but can also stay comfortable and sleep as necessary.
- For any person that is not referred by a medical facility, the CSFD CARES Team comes by twice a week and provides COVID testing for shelter residents.
- The Peak Vista medical van stops by M-F around 8 am to address any non-COVID medical issues and also helps determine when discharge from the HIS is appropriate.

 - The purpose of the Pikes Peak Veteran Housing Fund is to increase housing stability for vulnerable veteran households who are experiencing homelessness and are struggling to obtain safe, stable housing. By offering incentives and compensation to landlords if damage and unpaid rent are incurred, the Fund can create a strong relationship with landlords who otherwise might not lease to veteran individuals and families exiting homelessness.
