Approve October Meeting Minutes – Andy Barton

VOTE: Motion by Alison Gerbig for “Approval of the October 2020 minutes,” seconded by Laura Nelson, all in favor, motion passes.

Chair Elect Position – Andy Barton

Ask to the Board if anyone is interested in the Chair Elect position. Interested participants need to reach out to Andy for the Chair Elect Position prior to the next Board meeting. Vote on the Chair Elect position will be brought up during the next (January) Board meeting.

Discussion on Chris Garvin as an Ex Officio member of a voting member. The Board determines there is not a conflict of interest and recommends Chris as a voting member for future Board meetings.

Evan Caster to replace Jennifer Mariano on Statewide Collaborative effective 1/1/21 – Andy Barton

VOTE: Motion by Jeff Cook for “Approval to replace Evan with Jennifer on the COHMIS Statewide Collaborative effective January 1, 2021,” seconded by Noreen Landis Tyson, all in favor, motion passes.

2021 Unsheltered PIT Count – Andy Barton, Evan Caster, Jennifer Mariano

Board was presented with the options for an unsheltered Point In Time count to be conducted in January 2021. HUD allows for an exception given the current health crisis from CoCs to not conduct an unsheltered PIT count in 2021. The Executive Committee recommends to the Board to file for an exception and not conduct an unsheltered PIT count for purposes of safety. The Board agrees with the recommendation.

VOTE: Motion by Beth Roalstad for “The Board votes to not conduct an unsheltered PIT count in 2021 for the reasons of safety of staff, volunteers, and unsheltered population” seconded by Alison Gerbig, all in favor, motion passes.

2021 Unsheltered PIT Count – continued

Staff shares with the Board that HUD does offer alternative counting methods to surveying for the unsheltered PIT count including sampling, using existing HMIS data, and observation only counts.

The Board requests that the Administering Agency and HMIS Lead (Community Health Partnership) learn more about alternative sampling methods and decide if there is an equivalent substitute to submit for the 2021 unsheltered PIT count.

Racial Equity Among People Experiencing Homelessness, What Is Homeless Data Telling Us? What are the Next Steps? – Evan Caster

Staff presents to the Board on *Built for Zero* and *A Way Home America*. Data looks at veteran and youth homelessness out of the HMIS month-to-month: totals, inflows, outflows, eligibility, and demographic data. The data was presented around a lens of racial and ethnic equity. In addition to month comparisons, data was broken down by current living situation to look at how racial and ethnic minorities are disproportionately impacted by homelessness. The key takeaway is not from an immediate strategic decision-making perspective, but that data is available on these two important subpopulations of homelessness to analyze homelessness impacts based on race and ethnicity. The Board requests data being presented in a way to match existing U.S. Census definitions of race and ethnicity to more clearly compare the homeless population against the general racial and ethnic dynamics of El Paso County, CO. Additional request from the Board to look at Family Homelessness in a similar fashion.
