October 27, 2021	CoC R&P Committee hold Final Ranking Meeting to generate CoC Priority Listing with all project applications accepted and ranked, or rejected
November 1, 2021	Applicants will be notified in writing whether their applications will be accepted and ranked on the CoC Priority Listing, rejected, or reduced. Final Ranking and Prioritization will be posted on CHP NOFO webpage
November 8, 2021	CHP will post all parts of the CoC Consolidated Application (which are the CoC Application, CoC Priority Listing, and Project Applications) on CHP NOFO webpage for public comment
November 16, 2021	<b>DUE DATE</b> – 2021 PPCoC NOFO Collaborative Application due to HUD
