Example by Chris: El Paso County DHS was highlighted at the Statewide Colorado DHS meeting for their case management work on housing, participating in training on homelessness, and distribution of over \$250,000 in TANF funds to families facing housing insecurity

Build out media messaging

Balancing act of messaging around successes and identifying community needs, CoC has traditionally only emphasized the community needs (as is expected by HUD), but room for celebrating successes

Buy-in from non-providers like business community

Continue landlord engagement work in building out relationships

Other areas of discussion around school (McKinney Vento) involvement and respite care, spaces for continued growth in the next year
