## CoC Strategic Plan Activity, Influence vs. Impact Matrix – Evan

- **Impact** is how effective the objective and the strategic activities are in making homelessness Rare, Brief, and Non-Recurring.

- Decide as a group where Measurable Objectives go on Influence vs. Impact Matrix
- Use Strategic Plan and Strategic Activities listed under the Objectives to determine Influence vs. Impact
