Discussion on funding projects available

Annual Renewal Demand released this week, more CoC Bonus and DV Bonus available, more Planning <u>Meeting Discussion</u>

Challenges with CoC funding for the community and adding community capacity Alison talked about gaps for CoC funds, understanding the role of the CoC Board and their capacity Digging into the gaps of projects, how to build up community capacity and technical understanding Linking individual project performance to CoC Performance Measures

Annie: Outside capacity building grant, what would this look like to bring in a funder?

Annie: what is the organization capacity to manage grants, what is the technical assistance role of the CoC?

Andy Barton: strategic plan revisiting the plan, opportunity later this year while in-person Velda: Fostering Hope, interested in expanding capacity, direct to Evan for support

Review of Point in Time waiver with CSPD – Terry Anderson

Discussion on with Colorado Springs Police Department in participation in the annual Point in Time survey Redlining on PIT waiver from CSPD to participate in future surveying efforts

Meeting Discussion

Terry: Review of liability waiver took time due to shuffling of leadership within CSPD to talk about PIT, liability

Identifying CSPD as volunteers and their role would much better align to that of a participant

Unable to agree to video recording requirement on waiver because of taking photos/body cam in non-negotiable

Require them to sign a waiver, or not? Recommendation that it does not make sense Focus of waiver is largely on liability for CHP in the role of participation/volunteering

A question of whether CSPD has ever completed surveying? Historically yes, but does that makes sense?

A more important role to support the liability concerns would be in a participant role through public safety for volunteers

Questions on whether we are we able to talk to people we want to talk to? Does this erode trust?

Velda share her experience with CSPD HOT for vaccine distribution with Health Department Ability to support with other providers is the main focus of the CSPD

Legitimate safety concerns and where volunteers are sent for surveying, which is not into encampments, safety for providers would be more pressing

Question from Stephanie Johnson about the role of enforcement to have representation on the CoC Board

Discussion on inviting Brian Steckler, CSPD HOT Supervisor, to meeting, concerns about what would be the purpose and to not put him in a position where he has to defend the role of CSPD

CSPD was the convener for street outreach providers last year at Gold Hill in helping determine location for volunteering and deployment of street outreach teams

Homeward Pikes Peak riding along with CSPD regularly

Street Outreach Committee to help with identifying roles more clearly

Expressed concerns about CSPD's role last year with an example of CSPD arresting someone during surveying with street outreach providers, a requirement of CSPD to upload the law and how may that influence surveying (i.e., trust among people being surveyed)

Effectiveness of incentivizing volunteers of people with lived experience to help surveying Huge success led by Westside Cares and how to maximize with community support

No clear consensus on CSPD's role other than identifying that surveying would not be appropriate for CSPD to undertake and preference for allowing them to be volunteer safety supports
