- Stephanie Johnson stepping down when her term ends in December 2023.

## Role Changes:

Kristy Milligan – said she is willing to renew for another term and remain on the Executive Committee with role TBD.

Alison Gerbig – Will stay on board to complete term until December 2024 and stepping down from Chair role at end of 2023.

Haley Chapin and Andy Barton will term off of Executive Committee and will need to be replaced Tentative Timeline
