Questions from the Nominating Committee regarding alignment with Housing First open to Board discussion

Board discussed the importance of having a diversity of opinions as an important value add to the Board to lead the PPCoC

Holding different tools in the tool kit of homeless initiatives strategy is important and giving input in the process makes the collaborative stronger in its decision making

Important to recognize that standing up for the CoC priorities is inherent to the role, but that having an inclusive stance to homeless initiatives is foundational to supporting the community

Motion made by Terry to advance the full slate of Governing Board nominees to the Fall Membership meeting and to be voted on by the PPCoC Membership, Chris Garvin seconded, motion passes

# **General Updates** – CoC Board

Open to the Board members

City of Colorado Springs Mental Health and Homeless breakfast, role of the CoC Meeting Discussion

Discussion on City of Colorado Springs Mental Health and Homeless breakfast/summit

Concerns raised by Kristy on the conflation of Mental Health and Homelessness

Evan will be stepping back from Panelist and will be replaced by Alison

Real challenges on Housing Affordability and reference to Out of Reach report from the National Low Income Housing Coalition

Velda discussed the significant time commitment spent on people with serious mental illness cycling through various systems of impact, not inclusive of all homelessness but receives a lot of attention

Challenges with addressing underlying health conditions with experiencing homelessness

Differentiating between trauma and long-term mental illness

Perceptions of homelessness and stigma reduction, 1/4 households have mental health condition

Experiences are individualized and complex, addressing all components that lead to the whole

Fill in the gaps through a continuum and collaborative approach

The City should come to the CoC first not last, approaches in communication to be followed up after the event and how to effectively work together
